# County Councillor Report Cllr Michael Atkins, Hardwick Division November/December 2021

### Covid-19 Omicron variant and booster rollout

The new Omicron variant is of great concern, both locally and nationally. The transmissibility appears to be higher than the previously dominant Delta variant, but we have yet to see conclusive evidence on severity. Given the huge increase in the number of cases (now over 1,000 per week in South Cambridgeshire), the impact on health and education services willin any case be significant.

NHS staff are being redeployed to accelerate the rollout of booster jabs (third doses), which can now be booked by all adults via <u>www.nhs.uk/covidvaccine.</u>So far, over 300,000 boosters have been delivered in the Cambridgeshire & Peterborough area, leaving an estimated 300,000 further adults requiring boosters. You can pre-book from two months after your second dose, and will be offered slots from three months after your second dose.

Boosters are no longer being offered on a walk-in basis. Although this is popular with some members of the public, in other areas of the country it has led to significant queuing, which is problematic from a disease-control perspective, and for those with disabilities or who are pregnant. First and second doses can still be accessed on a walk-in basis.

You may find that some routine, non-emergency health services will temporarily be paused or scaled down, which could lead to appointment delays or cancellation, whilst the booster rollout operates at a high pace. We have been assured that this will be monitored carefully and that appointments will only be changed if it is clinically safe to do so.

All of the previous advice continues to apply – get vaccinated, meet people outdoors where possible, wear masks and improve ventilation when indoors.

You may have seen in the media that a recent all-councillor meeting of the County Council scheduled for 14<sup>th</sup> December was cancelled following advice from our Director of Public Health. Unfortunately the provision in law for local democracy to operate remotely expired earlier this year and the Westminster government has not re-introduced it. It was also not possible to agree across parties to reduce the number of councillors attending to a manageable level. The smaller committee meetings of the Council have continued in large, well-ventilated rooms.

### Household support fund

The Council has been allocated £3.5m in funding to help people who need financial support this winter. Approximately £1m will be used to continue the offer of supermarket vouchers to eligible families (typically those in receipt of free-school meals or other

benefits) to cover food costs during the school holidays. The remainder will be deployed flexibly to help households with heating, food, and other essential suppliers. ### Holiday activities and food programme

There are places still available for the council's Holiday Activities Programme, which are free of charge for children in receipt of free school meals and/or similar benefits.

There are huge well-being and social engagement benefits for children and young people attending a holiday scheme or family experience, and the Council is supporting them to comply with all safety and Covid requirements. Food hampers will also be made available to families that book through the programme. Many local children and families are missing out on opportunities because they lack access to digital services. The Council (and partners) are therefore accepting donations of old and unwanted devices, which will be refurbished by volunteers and given to families in need. ### Roman history unearthed in Cambridgeshire

Stepping outside of current news, archaeologists investigating a Roman settlement in Cambridgeshire have found evidence of a person killed by crucifixion, which would be the first documented case in the UK. County archaeologist KasiaGdaniec says "These cemeteries and the settlement that developed along the Roman road at Fenstanton are breaking new ground in archaeological research. Burial practices are many and varied in the Roman period and evidence of ante-or post-mortem mutilation is occasionally seen, but never crucifixion. We look forward to finding out more when the results are published. Hopefully, there will be a museum exhibit to showcase the remains soon, and we are working to arrange this."

# COVID19 UPDATE

COVID case rates are increasing dramatically across Cambridgeshire and Peterborough. South Cambs case numbers are currently at 1,384 cases per 100,000 people (compared with 562 per 100,000 as of 26<sup>th</sup> November). The East of England average is 1,617 cases per 100k people. Most cases are now in the working age population as it seems Christmas has likely reduced transmission in schools. There is concern of a rapid increase in rates in those people aged over 60 as children return to schools with potential for Omicron to spread.

The vaccination programme remains key to tackling the virus. Where possible, continue to work from home and follow guidance Hands-Face-Space-Fresh Air. Please get vaccinated, take a free rapid lateral flow test before going out to crowded places to ensure you are unlikely to spread the virus. Pick up home test kits from pharmacies and libraries, order online. www.cambridgeshire.gov.uk/rapidtesting

From 11 January in England, people who receive positive lateral flow device test results for COVID-19 will be required to self-isolate immediately and will not be required to take a confirmatory PCR. <u>https://www.gov.uk/government/news/confirmatory-pcr-tests-to-be-temporarily suspended-for-positive-lateral-flow-test-results</u> This is a temporary measure.

It is now possible to end self-isolation after 7 days, following 2 negative LFD tests taken 24 hours apart. The first LFD test should not be taken before the sixth day. The full government guidance is at <u>https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance</u>

### Long COVID - Help and support

On 24 December 2021, the Department of Health and Social Care updated the guidance for those who have long COVID. Also updated is advice for those who have signs and symptoms of long COVID, those who have long COVID and are unable to work, those who have long COVID and need support to find, return to or stay in work, and for those who have a child with long COVID. ### Green Bin Collections proposed resumption

The Greater Cambridge Waste Service suspended green bin collections on 13 December 2021 due to Covid-related staff shortages (sickness and self-isolation). This was compounded by a national shortage of HGV drivers and demand for agency staff. We are expecting the resume this service on 12<sup>th</sup> January 2022, but please check the Council website <u>https://www.scambs.gov.uk/recycling-and\_bins/</u> and social media accounts for updates. Greater Cambridge Local Plan – First Proposals Consultation Thank you to everyone who took the time to respond to the First Proposals consultation that closed on 13 December 2021. The Planning Policy team will over the next few months be trawling through the responses, collating them and use the information to refine the proposals and turn them into the draft local plan. I will keep you updated on progress as and when appropriate. We expect to be able to consult on the draft local plan later this year. ## Area 3 Planning Meeting

Thank you to the Parishes that sent representatives to the quarterly Area 3 Planning Meeting in December. I hope you found it useful. These sessions are an important opportunity for parish councils to interact directly with the Planning officers responsible for dealing with cases in our ward villages, and also to learn more about some of the planning process. At the last meeting, the Area Team Leader gave an update on staff, workload and applications potentially going to committee in the new year. This was followed by various officers of the shared service giving updates and then the presentation on Section 106 agreements which was followed by updates in the National Planning Policy Framework (NPPF), the Government rules on planning!

I encourage each Parish to make it a point to send representatives (councillors and/or parish clerks). The next meetings should be late Feb/early March 2022.

# Transport

I hope many were able to respond to the Greater Cambridge Partnership (GCP) public consultation titled Making Connections. I sent in a response and some of my comments included: • Linking clusters of villages by very good network of walking and cycling routes so that residents can move more freely within them to access local services and other transport. For example connecting Longstowe & Wysing Arts to Bourn, then Bourn to Caldecote. • Also linking Bourn, Caldecote, Kingston and Hardwick to Toft and Comberton for access to the Village college. This could be achieved by extending the proposed Comberton Greenway westwards

• Return the bus service that went through Caldecote before subsidies were removed • Gave a preference for low cost flat fares and flexible season ticket options.

Transport is the greatest generator of carbon and so we need to radically rethink how we move about. The more we contribute to the debate, the better we can get what we need for our villages. I should hope that COP26 is still very much in our minds and what we need to do. Now we wait and see what the results of that consultation will be.
